- Focus on facts, issues and proposals, (no name calling, no personal attacks, no false accusations), Use attribution of sources and documentation when making statements about other people or groups},
- Honor board confidentiality, keeping all KPFA job performance information confidential to be shared only within closed session
- Video Recording is not permitted at LSB meetings.
